College is required to follow standard guidelines in the functioning as under:

- Case records should be well maintained with case analysis, evaluation and repertorization and made available in the Medical Record Room for academic purpose of students and follow up attendance of patients.
- Case sheets should have complete demographic details and contact details of patients.
- Diagnosis should be written in ICD 11 criteria

Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy and the penalty as decided will be imposed in such cases. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.


The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.

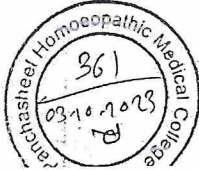


